## **ANNOUNCEMENTS & COMMENTS FROM SUSTAINABLE CITY COMMISSIONERS**

Commissioner Greenwood thanked Larry Rich, Sustainability Coordinator, and his bioneers for helping at Cressa Park. Cressa Park is a volunteer effort to establish an all native green belt in the Wrigley District. Because of the rain, there was an incredible flourishing of weeds and the young kids worked very, very hard; filling 70 trash bags with weeds. Only a third of the site has been completed. There are still several piles and community volunteers will continue on Sunday, March 26, 2011. Of all the volunteer youth groups, these bioneers are by far the best; some remained until 4:00 p.m.

Commissioner Supernaw had two announcements:

The first, there is a planning meeting tonight regarding Orizaba Park at Lee Elementary School on Temple, south of PCH. There has already been a groundbreaking...everyone should attend and voice their opinion.

Amy Bodek, Director of Development Services, responded regarding Orizaba Park. Erika Martin, Redevelopment Administrative Analyst, will be leading the meeting on behalf of staff. The groundbreaking was for the park and the design meeting is for the community building which has not yet been designed but has received grant funding from the state.

Commissioner Supernaw continued by saying this is the type of thing where a lot of folks will attend for the groundbreaking...this is really where you need the community input. Years ago, according to Commissioner Supernaw, that piece of property still had the railroad tracks on it and a box car sitting there, so this is a great improvement.

The next item mentioned by Commissioner Supernaw is the Orange County Transportation Authority CalTrans Project to demolish the 7th Street Bridge. By the time of the next Sustainable City Commission meeting that bridge will have been down for about ten days. This is incredibly impactful for the Fourth, Third & Fifth Districts. The car miles traveled on a daily basis because of the detours will be between 30,000 and 150,000 miles per day; a huge impact.

And finally, Commissioner Supernaw once again congratulated kW Engineering.

Commissioner White-Kjoss spoke regarding the Gerald Desmond Bridge. The Bike & Pedestrian Path has been stated as a required part of the Gerald Desmond Bridge redesign and construction. The RFPs that go out will have sections that require the design team to include that as apart of the project. That became a required part of the project last Monday, March 21, 2011 at the Harbor Commission meeting, where a couple of the leaders in this movement for the Bike & Pedestrian Path on the Gerald Desmond Bridge spoke one more time. It was a very significant event as just two days after the ruling, the leader of that movement, Mark Bixby, passed away in a plane crash in Long Beach. A memorial ride will be held on Friday March 25, 2011 starting at Leeway Sailing Center beginning at 8 a.m. and riding to the top of the Gerald Desmond Bridge for a celebration of Mark's life. It will be a wonderful ride to share the dream of all people being able to use the bridge instead of just auto drivers.

Commissioner Greenwood made another announcement about a meeting tonight at 7 p.m. at Silverado Park. The AQMD and the West Long Beach Association in the 7th District Council office will be doing a presentation on zero emission vehicles and they will have a zero emission truck there for people to see. After doing research on the internet, it was surprising to find that a local firm, Vision Motors, does have a heavy duty truck out there that has passed its second stage testing and is now going into pre-production and our ports will be evaluating them as cargo hauling trucks. They are cheaper to operate than natural gas powered or diesel trucks, they also operate more quietly and they have a range of 150 to 400 miles. They make a very viable argument for perhaps not expanding those troublesome rail yards that have been polluting the Westside schools.

Commissioner Gonzalez announced the 3rd Annual Green Long Beach Festival. For those unfamiliar with the event, it is a grass roots event meant to bring together businesses, non-profits, city agencies and various other government agencies to celebrate one of the common missions which is to create a greener life style or greener City.
