INTERGOVERNMENTAL AGREEMENT AMENDMENT NO. 2

SUPPLEMENTAL LAW ENFORCEMENT SERVICES AGREEMENT

THIS AMENDMENT NO. 2 TO INTERGOVERNMENTAL AGREEMENT is made and entered into this 30th day of June, 2022 by and between the Los Angeles County Development Authority, herein referred to as the "LACDA" and the City of Long Beach ("CITY") and Long Beach Police Department, a CITY department ("DEPARTMENT). The LACDA, CITY, and the DEPARTMENT are herein referred to as collectively the ("Parties").

WITNESSETH THAT:

WHEREAS, the LACDA, CITY and the DEPARTMENT entered into an original Intergovernmental Agreement on January 27, 2021 to provide supplemental law enforcement services to the LACDA at the Carmelitos public housing development.

WHEREAS, on June 30, 2021 Amendment No. 1 was executed to increase the Intergovernmental Agreement Price by \$506,695.43 for the period of July 1, 2021 through June 30, 2022 for a total agreement price not to exceed \$745,961.43; and replace Exhibit A- Supplemental Law Enforcement Service Costs with Exhibit A-1 Supplemental Law Enforcement Service Costs.

WHEREAS, the Parties mutually agree it is to their benefit to execute Amendment No. 2 to increase the Intergovernmental Agreement Price by \$512,094.68 for the period of July 1, 2022 through June 30, 2023 for a total agreement price not to exceed \$1,258,056.11; and replace Exhibit A- Supplemental Law Enforcement Service Costs with Exhibit A-2 Supplemental Law Enforcement Service Costs.

NOW, THEREFORE, in consideration of the mutual undertakings herein, the parties hereto agree that said Intergovernmental Agreement will be amended as follows:

1. Section 4.0 Term of Agreement, is deleted in its entirety and replaced as follows:

4.1 Term

This Intergovernmental Agreement shall commence on January 1, 2021 and shall remain in force and effect until June 30, 2023, unless sooner terminated as provided herein LACDA shall have the sole option to extend this Contract term for up to two additional one (1) year periods, through June 30, 2025.

2. Section 5.0 Agreement Price and Rates, Paragraph 5.1 is deleted in its entirety and replaced as follows:

Section 5.1 Total Agreement Price

The Intergovernmental Agreement Price for the Supplemental Law Enforcement Services shall be increased to add \$512,094.68 for the period of July 1, 2022

through June 30, 2023 for a total agreement price not to exceed \$1,258,056.11 ("Intergovernmental Agreement Price") for the term of this Agreement as set forth in Paragraph 4.0 Term of Agreement. Any increases to the Intergovernmental Agreement Price must be made through written amendment to this Agreement, executed by the LACDA, CITY and the DEPARTMENT.

3. Exhibit A- 1 Supplemental Law Enforcement Service Costs, is deleted in its entirety and replaced by Exhibit A-2 Supplemental Law Enforcement Service Costs (attached hereto and incorporated herein as referenced). Any references made to Exhibit A-1 Supplemental Law Enforcement Service Costs in the Contract shall hereafter be referenced as Exhibits A-2 Supplemental Law Enforcement Service Costs.
