FIRST AMENDMENT TO CONTRACT NO. 29700

THIS FIRST AMENDMENT TO CONTRACT NO. 29700 is made and entered, in duplicate, as of June 26, 2008, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 13, 2006, by and between NOBEL SYSTEMS, a California corporation ("Vendor") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Contract No. 29700 (the "Contract") whereby Vendor agreed to provide GIS mapping services to the City of Long Beach; and

WHEREAS, the parties desire to extend the term of the Contract so that Vendor can complete the services previously authorized by the City.

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract, the parties agree as follows:

1. The term of the contract is hereby extended from June 25, 2008 until such time as Vendor has completed furnishing to City the services called for under the Contract, or until such time as the Contract is sooner terminated by City.

2. Except as expressly amended herein, all of the terms and conditions of the Contract are ratified and confirmed and shall remain in full force and effect, and nothing in this Amendment shall increase the compensation to be paid to Vendor under the Contract.




