1 FIRST AMENDMENT TO AGREEMENT NO. 35644

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35644 is made and
4 entered, in duplicate, as of July, 26, 2021 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on March 10,
6 2020, by and between PP-CA LP, DBA LONG BEACH ANIMAL EMERGENCY, a
7 California limited partnership ("Contractor"), with a place of business at 4720 E. Pacific
8 Coast Highway, Long Beach, California, 90804, and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with emergency after-hours veterinary services (EVS); and

12 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
13 35644 (the "Agreement") whereby Contractor agreed to provide these services; and

14 WHEREAS, the Parties desire to extend the term one additional one-year
15 period;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the Parties agree as follows:

18 1. Section 2 of the Agreement is hereby amended to read as follows:

19 "2. TERM. The term of this Agreement shall commence at midnight on
20 October 1, 2019, and shall terminate at 11:59 p.m. on September 30, 2022, unless sooner
21 terminated as provided in this Agreement. City shall have the option to extend the term of
22 this Contract for two (2) additional one-year periods, at the discretion of the City Manager."

23 2. Except as expressly modified herein, all of the terms and conditions
24 contained in Agreement No. 35644 are ratified and confirmed and shall remain in full force
25 and effect.
