1 SEVENTH AMENDMENT TO AGREEMENT NO. 33926

3 THIS SEVENTH AMENDMENT TO AGREEMENT NO. 33926 is made and
4 entered, in duplicate, as of March 8, 2023 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on July 5, 2022,
6 by and between ARCHITECTS MCDONALD, SOUTAR & PAZ, INCORPORATED, a
7 California corporation ("Consultant"), with a place of business at 3575 Long Beach Blvd.,
8 Long Beach, California 90807, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 33926 (the "Agreement") whereby Consultant agreed to provide as-needed architectural
12 services in a total not to exceed amount of Four Hundred Thousand Dollars (\$400,000) for
13 a period of two (2) years with the option to extend for three (3) additional one-year periods;
14 and

15 WHEREAS, the Parties entered into a First Amendment to the Agreement to
16 extend the term to July 19, 2018; and

17 WHEREAS, the Parties entered into a Second Amendment to the Agreement
18 to add Two Hundred Thousand Dollars (\$200,000) for a total not to exceed amount of Six
19 Hundred Thousand Dollars (\$600,000) and extend the term to July 19, 2019; and

20 WHEREAS, the Parties entered into a Third Amendment to the Agreement
21 to extend the term to July 19, 2020; and

22 WHEREAS, on June 9, 2020, City Council approved extending the
23 Agreement one (1) additional one-year period; and

24 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
25 to extend the term to July 19, 2021; and

26 WHEREAS, on June 8, 2021, City Council approved extending the
27 Agreement one (1) additional one-year period; and

28 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to

1 extend the term to July 19, 2022; and

2 WHEREAS, the Parties entered into a Sixth Amendment to add Two Hundred
3 Fifty Thousand Dollars (\$250,000) for a total not to exceed amount of Eight Hundred Fifty
4 Thousand Dollars (\$850,000), extend the term one (1) additional one-year period, update
5 the City Representative and attach an updated rate sheet;

6 WHEREAS, Parties desire to add Two Hundred Thousand Dollars
7 (\$200,000) for a total not to exceed One Million Fifty Thousand Dollars (\$1,050,000) to the
8 Agreement;

9 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
10 conditions herein contained, the Parties agree as follows:

11 1. Section 1.A. of the Agreement is hereby amended to read as follows:

12 "A. Consultant shall furnish specialized services more particularly
13 described in Exhibit "A", attached to this Agreement and incorporated by this
14 reference, in accordance with the standards of the profession, and City shall pay for
15 these services in the manner described below, not to exceed One Million Fifty
16 Thousand Dollars (\$1,050,000), at the rates or charges shown in Exhibit "B-1".

17 2. Except as expressly modified herein, all of the terms and conditions
18 contained in Agreement No. 33926 are ratified and confirmed and shall remain in full force
19 and effect.
