1 FIRST AMENDMENT TO AGREEMENT NO. 33773

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33773 is made and
4 entered, in duplicate, as of January 17, 2017 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 2, 2014, by and between DYETT & BHATIA, URBAN AND REGIONAL
7 PLANNERS, a California corporation, with a place of business at 755 Sansome Street,
8 Suite 400, San Francisco, California 94111 ("Consultant"), and the CITY OF LONG
9 BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed on-call planning consulting services; and

12 WHEREAS, City and Consultant entered into Agreement No. 33773 (the
13 "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, City and Consultant desire to increase the total not to exceed
15 amount to \$300,000 and extend the term an additional one (1) year period;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of the Agreement is hereby amended to read as follows:

19 "A. Consultant shall furnish specialized services more particularly
20 described in Exhibit "A", attached to this Agreement and incorporated by this
21 reference, in accordance with the standards of the profession, and City shall pay for
22 these services in the manner described below, not to exceed Three Hundred
23 Thousand Dollars (\$300,000), at the rates or charges shown in Exhibit "B".

24 2. Section 2 of the Agreement is hereby amended to read as follows:

25 "2. TERM. The term of this Agreement shall commence at midnight on
26 January 1, 2015, and shall terminate at 11:59 p.m. on December 31, 2017, unless sooner
27 terminated as provided in this Agreement, or unless the services or the Project is
28 completed sooner. The parties have the option to extend the term one (1) additional one-


1 year period.”

4 and effect.




