RESOLUTION NO. O.B. 06-2014

A RESOLUTION OF THE OVERSIGHT BOARD OF THE CITY OF LONG BEACH AS THE SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF LONG BEACH APPROVING THE SUCCESSOR AGENCY'S ACTION TO 1) TRANSFER OWNERSHIP OF ASSESSOR PARCEL NUMBERS 7280-005-922 AND 7280-005-923, ALSO KNOWN AS HARVEY MILK PARK, TO THE CITY OF LONG BEACH; 2) AUTHORIZE THE CITY MANAGER AND DIRECTOR OF DEVELOPMENT SERVICES TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY TO COMPLETE THE TRANSFER UPON APPROVAL BY THE STATE OF CALIFORNIA DEPARTMENT OF FINANCE; AND 3) ACCEPT THE CATEGORICAL EXEMPTION CE 14-093

WHEREAS, the Successor Agency to the Redevelopment Agency of the City of Long Beach ("Successor Agency") currently owns the property known as Harvey Milk Park, Assessor Parcel Numbers 7280-005-922 and 7280-005-923 ("Subject Property"); and

WHEREAS, in compliance with AB1484, the Successor Agency submitted its Long Range Property Management Plan ("LRPMP") to the California State Department of Finance for review in October 2013; and

WHEREAS, the LRPMP categorizes the Subject Property as a Government Use parcel as it is currently utilized as a public park; and

WHEREAS, Section 34181(a) and Section 34191.3 of the Health and Safety Code allow for the transfer of Government Use properties prior to the approval of

1 the LRPMP; and

2 WHEREAS, the Successor Agency would like to convey the Subject
3 Property to the City of Long Beach; and

4 WHEREAS, this matter was approved by the Successor Agency to the
5 Redevelopment Agency of the City of Long Beach on September 16, 2014;

6 NOW, THEREFORE, the Oversight Board of the City of Long Beach as the
7 Successor Agency to the Redevelopment Agency of the City of Long Beach ("Oversight
8 Board") resolves as follows:

9 Section 1. Approve the decision of the Successor Agency to the
10 Redevelopment Agency of the City of Long Beach to 1) transfer ownership of Assessor
11 Parcel Numbers 7280-005-922 and 7280-005-923, also known as Harvey Milk Park, to
12 the City of Long Beach; 2) authorize the City Manager and Director of Development
13 Services to execute any and all documents necessary to complete the transfer upon
14 approval by the State of California Department of Finance; and 3) accept the Categorical
15 Exemption CE 14-093.

16 Section 2. This resolution shall take effect immediately upon its adoption
17 by the Oversight Board, and the City Clerk shall certify the vote adopting this resolution.
