RECOMMENDATION:

Adopt a Resolution authorizing the temporary closure of certain streets, alleys, walkways, The Promenade, and the downtown shoreline bike path in the City of Long Beach in connection with the conduct of the 2019 Grand Prix of Long Beach. (District 2)

DISCUSSION

On April 12 through 14, 2019, the 45th Annual Grand Prix of Long Beach will be held on the streets of Long Beach. This event will attract over 180,000 people to the city and receive national and international media coverage. City Council adoption of the Resolution authorizes the temporary closure, and proposed schedule, of certain streets, alleys, walkways, The Promenade, and the downtown shoreline bike path so the race may be held on City streets. The bike path, beginning at Seaside Way and Chestnut Place, and continuing to a point approximately 400 feet east of the beach parking, must be closed during the race to allow fire trucks and medical vehicles continual access to the back side of the bleachers situated on the north and south sides of Shoreline Drive. The Departments of Fire, Gas and Oil, Water, Police, Public Works, Financial Management, Development Services, Health and Human Services, and Parks, Recreation and Marine, as well as Long Beach Transit, have reviewed the proposed schedule.

Traffic management and signage plans will be forwarded to newspapers serving the greater Long Beach area asking for their cooperation to publicize these plans as a public service during the weeks prior to the race.

This matter was reviewed by Deputy City Attorney Richard F. Anthony on November 5, 2018 and by Budget Analysis Officer Julissa José-Murray on October 31, 2018.

TIMING CONSIDERATIONS

City Council approval is requested on January 8, 2019, in order to expedite the execution of the Resolution. Construction for the 2018 Toyota Grand Prix of Long Beach begins on February 18, 2019.

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH TO TEMPORARILY CLOSE AND REMOVE FROM PUBLIC USE CERTAIN STREETS, ALLEYS, WALKWAYS, THE PROMENADE AND DOWNTOWN SHORELINE BIKE PATH IN THE CITY OF LONG BEACH IN CONNECTION WITH THE CONDUCT OF THE 2019 GRAND PRIX OF LONG BEACH

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach finds and determines that the conduct of the 2019 Grand Prix of Long Beach on the streets of the City of Long Beach and the coverage thereof by the media provides a unique opportunity for the City of Long Beach to publicize and call attention to the City, its natural advantage, resources, enterprises, attractions, climate and facilities.

Section 2. For the conduct of the 2019 Grand Prix of Long Beach, the following streets will hereby have temporary lane reductions for the periods stated:

A. From February 18, 2019 at 9:00 a.m. to May 5, 2019 at 11:59 p.m., Shoreline Drive westbound from Ocean Boulevard to Long Beach Arena service road (reduce existing three lanes to two lanes).

B. From February 18, 2019 at 7:00 a.m. to May 5, 2019 at 11:59 p.m., Shoreline Drive eastbound from Linden Avenue to Ocean Boulevard (reduce existing three lanes to two lanes).

C. From February 22, 2019 at 7:00 a.m. to April 25, 2019 at 11:59 p.m., Seaside Way from Pine Avenue to Linden Avenue (reduce existing two lanes to one lane in each direction, with placement of

1 temporary stop signs at Seaside Way/Locust Avenue, Seaside Way/Collins
2 Way, Seaside Way/Hart Place and Seaside Way/Linden Avenue.
3 Intersection signage to be placed by City).

4 D. From February 28, 2019 at 7:00 a.m. to April 19, 2019 at
5 11:59 p.m., Pine Avenue from Ocean Boulevard south to Upper Esplanade
6 (reduce existing five lanes to three lanes).

7 Section 3. For the conduct of the 2019 Grand Prix of Long Beach, the
8 following streets, alleys, promenade, walkways, and bike path are hereby temporarily
9 closed for the periods stated:

10 A. On April 2, 2019 from 7:00 a.m. to 5:00 p.m., Shoreline Drive
11 eastbound from Broadway off-ramp to Ocean Boulevard, Shoreline Village
12 Drive to Shoreline Drive eastbound and westbound, Shoreline Drive
13 westbound from Ocean Boulevard to Chestnut Place northbound.

14 B. On April 2, 2019 from 4:00 a.m. to 5:00 p.m., Golden Shore
15 on-ramp to Shoreline Drive eastbound, Chestnut Place northbound and
16 southbound from Seaside Way to Queensway Bridge, Seaside Way from
17 Pine Avenue to eastern end of Seaside Way, Aquarium Way from Shoreline
18 Drive to Chestnut Avenue, Hart Place from Seaside Way to Ocean
19 Boulevard, Collins Way from Seaside Way to Ocean Boulevard, Cedar
20 Avenue at Shoreline Drive, Linden Avenue from Ocean Boulevard to
21 Shoreline Drive, Bay Street at Pine Avenue and The Paseo at Pine Avenue.

22 C. On April 2, 2019 from 9:45 a.m. to 10:15 a.m., 10:45 a.m. to
23 11:15 a.m., 1:15 p.m. to 1:45 p.m., and 2:15 p.m. to 2:45 p.m., Pine Avenue
24 from Ocean Boulevard to Upper Esplanade, Linden Avenue from Ocean
25 Boulevard to Shoreline Drive, Seaside Way from Linden Avenue to Marina
26 Way (eastern end).

27 D. From April 10, 2019 at 5:00 a.m. to April 15, 2019 at 5:00
28 p.m., Seaside Way from Pine Avenue to eastern end of Seaside Way,

1 Linden Avenue from Ocean Boulevard to Seaside Way, Marine Way from
2 Locust Avenue to Collins Way, Atlantic Way from Ocean Boulevard to
3 Seaside Way, Marine Way from Hart Place to eastern end, Linden Avenue,
4 northbound and southbound from Shoreline Drive to Marina Parking lot,
5 Locust Avenue from Ocean Boulevard to Seaside Way, Cedar Avenue at
6 Shoreline Drive, Bay Street at Pine Avenue, The Paseo at Pine Avenue and
7 Aquarium Way from Shoreline Drive to Chestnut Avenue.

8 E. From April 10, 2019 at 7:00 a.m. to April 15, 2019 at 5:00
9 p.m., Shoreline Drive westbound from Ocean Boulevard and Alamitos
10 intersection to 3rd Street on-ramp northbound, Chestnut Avenue
11 southbound and northbound from Seaside Way to Queensway Bridge,
12 Aquarium Way from Shoreline Drive to Chestnut Place, and Cedar Avenue
13 at Shoreline Drive.

14 F. From April 10, 2019 at 3:00 p.m. to April 15, 2019 at 5:00
15 p.m., Shoreline Drive eastbound from Broadway off-ramp to Ocean
16 Boulevard and Alamitos intersection, Golden Shore on-ramp to Shoreline
17 Drive eastbound, Shoreline Village Drive from Marina Parking lot to
18 Shoreline Drive.

19 G. On April 12, 13, and 14, 2019 from 6:00 a.m. to 7:00 p.m.,
20 Pine Avenue from Ocean Boulevard to Upper Esplanade.

21 H. On April 12, 13, and 14, 2019 from 6:00 a.m. to 7:00 p.m.,
22 Promenade South from Seaside Way to Shoreline Drive Terminus.

23 I. On April 12, 13, and 14, 2019 from 6:00 a.m. to 7:00 p.m.,
24 walkway off of Seaside Way from Hart Place to the east end of Seaside
25 Way.

26 J. From April 10, 2019 at 7:00 a.m. to April 15, 2019 at 11:59
27 p.m., the Bike Path beginning at Seaside Way and Chestnut Avenue east to
28 a point approximately four hundred feet (400') east of the permanent

1 concession stand behind the Villa Riviera.

2 K. From February 18, 2019 through May 5, 2019, Shoreline
3 Drive from Ocean Boulevard to Shoreline Village Drive, Aquarium Way
4 between Shoreline Drive and Chestnut Place, and Pine Avenue between
5 Seaside Way and Shoreline Drive, intermittently at the discretion of the City
6 Manager, or his designee, in order to allow for pedestrian bridge placement
7 and removal, but only during the hours from 10:00 p.m. to 8:00 a.m.

8 Section 4. The temporary closing of the above streets, alleys, walkways,
9 promenade and bike path for the times herein provided is necessary for the safety and
10 protection of the participants and spectators in the 2019 Grand Prix of Long Beach and
11 qualifying events to be held from April 12, 2019 through April 14, 2019, utilizing the
12 streets described herein.

13 Section 5. For the period of 4:00 a.m. to 5:00 p.m. on April 2, 2019, the
14 streets and alleys described in Sections 3.A. through 3.C. are hereby withdrawn and
15 removed from public use.

16 Section 6. For the period April 10, 2019 at 5:00 a.m. to April 15, 2019 at
17 5:00 p.m., the streets and alleys described in Section 3.D. are hereby withdrawn and
18 removed from public use.

19 Section 7. For the period April 10, 2019 at 7:00 a.m. to April 15, 2019 at
20 5:00 p.m., the streets and alleys described in Section 3.E. are hereby withdrawn and
21 removed from public use.

22 Section 8. For the period April 10, 2019 at 3:00 p.m. to April 15, 2019 at
23 5:00 p.m., the streets and alleys described in Section 3.F. are hereby withdrawn and
24 removed from public use.

25 Section 9. On April 12, 13, and 14, 2019 from 6:00 a.m. to 7:00 p.m., the
26 streets, promenade and alleys described in Sections 3.G. through Section 3.I. are hereby
27 withdrawn and removed from public use.

28 Section 10. For the period April 10, 2019 at 6:00 a.m. to April 15, 2019 at

1 11:59 p.m., the bike path described in Section 3.J. is hereby withdrawn and removed
2 from public use.

3 Section 11. From February 18, 2019 through May 5, 2019, the streets and
4 alleys described in Section 3.K. are hereby intermittently withdrawn and removed from
5 public use at the discretion of the City Manager, or his designee, in order to allow for
6 pedestrian bridge placement and removal.

7 Section 12. The City Manager, or his designee, is authorized and directed
8 to post notices of the intent to temporarily reduce lanes, close the streets, alleys,
9 walkways and portions of the promenade described in Sections 2, 3, 4, 5, 6, 7, 8, 9, 10
10 and 11 above at least twenty-four (24) hours prior to the closure thereof.

11 Section 13. This resolution shall take effect immediately upon its adoption
12 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
