

RESOLUTION NO. RES-05-0076

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE THREE (3) WEAPONS OF MASS DESTRUCTION SUPPORT VEHICLES AND ONE (1) DIVE SUPPORT UNIT THROUGH THE CONTRACT BETWEEN SAN LUIS OBISPO COUNTY AND PLACER FIRE EQUIPMENT, INC.

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase three (3) weapons of mass destruction support vehicles and one (1) dive support unit; and

WHEREAS, San Luis Obispo County has a contract for the purchase of these items ("San Luis Obispo Contract"); and

WHEREAS, City's participation in the San Luis Obispo Contract will facilitate acquisition of these items as well as provide considerable costs benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the San Luis Obispo Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated hereby by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Placer Fire Equipment, Inc. to purchase three (3) weapons of

1 mass destruction vehicles and one (1) dive support unit of substantially the same type and  
2 kind purchased by San Luis Obispo County pursuant to the San Luis Obispo Contract  
3 except as modified by mutual agreement of the City of Long Beach and Placer Fire  
4 Equipment, Inc. and the purchase by the City of Long Beach shall be on the same terms  
5 and conditions afforded to San Luis Obispo County in an amount not to exceed  
6 \$981,909.00 including tax, for a period extending until the warranty on the vehicles expire.

7 Sec. 3. This resolution shall take effect immediately on its adoption by the  
8 City Council, and the City Clerk shall certify the vote adopting this resolution.
