1 FIRST AMENDMENT TO AGREEMENT NO. 34149

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34149 is made and
4 entered, in duplicate, as of January 31, 2017 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 20, 2015, by and between THE KAP AGENCY, a sole proprietorship
7 ("Consultant"), with a place of business at 115 Pine Avenue, Suite 360, Long Beach,
8 California 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with as-needed graphic design and creative services; and

11 WHEREAS, City and Consultant entered into Agreement No. 34149 (the
12 "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, City and Consultant desire to increase the total not to exceed
14 amount to \$146,500;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 1.A. of the Agreement is hereby amended to read as follows:

18 "A. Consultant shall furnish specialized services more particularly
19 described in Exhibit "A", attached to this Agreement and incorporated by this
20 reference, in accordance with the standards of the profession, and City shall pay for
21 these services in the manner described below, not to exceed One Hundred Forty-
22 Six Thousand Five Hundred Dollars (\$146,500), at the rates or charges shown in
23 Exhibit "B".

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 34149 are ratified and confirmed and shall remain in full force
26 and effect.
