1 TWELFTH AMENDMENT TO CONTRACT NO. 29298

3 THIS TWELFTH AMENDMENT TO CONTRACT NO. 29298 is made and
4 entered, in duplicate, as of May 16, 2008 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on July
6 19, 2005, by and between RAINBOW HARBOR PARTNERS, LLC, a California limited
7 liability company ("V2O") and the CITY OF LONG BEACH, a municipal corporation
8 ("City").

9 WHEREAS, the Long Beach Police Department ("LBPD") provides public
10 law enforcement services within the City of Long Beach; and

11 WHEREAS, V20 has requested that City provide supplemental law
12 enforcement services in the public area near its night club facility commonly known as
13 "V20" ("the Facility") located in the Pike Entertainment Complex over and above the law
14 enforcement services provided to the public generally; and

15 WHEREAS, the parties entered Contract No. 29298 and certain
16 amendments thereto (as amended, the "Contract") whereby City agreed to provide
17 supplemental law enforcement services on an occasional basis to V20 as such services
18 are needed; and

19 WHEREAS, the parties desire to extend the term of the Contract and
20 increase officer wages as indicated on exhibit "A" attached;

21 NOW, THEREFORE, in consideration of the mutual terms and conditions in
22 the Contract, the parties agree as follows:

23 1. The term of the Contract is hereby extended so that the Contract will
24 remain in effect through August 15, 2008.

25 2. Police Officer wages will be increased as indicated on exhibit "A"
26 attached.

27 3. Except as expressly amended herein, all of the terms and conditions of
28 the Contract are ratified and confirmed and shall remain in full force and effect.
