THIS FIRST AMENDMENT TO EMERGENCY SOLUTIONS CONTRACT NO. 33326 is made and entered, in duplicate, as of August 25, 2014 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 10, 2013, by and between CATHOLIC CHARITIES OF LOS ANGELES, INC., a California nonprofit corporation ("Organization"), with offices located at 1531 James M. Wood Boulevard, Los Angeles, California 90015-0095, and the CITY OF LONG BEACH, a municipal corporation (the "City").

WHEREAS, the City has received a grant from the U.S. Department of Housing and Urban Development ("HUD") for a program to provide emergency housing and rapid re-housing assistance for homeless individuals; and

WHEREAS, as part of the Grant Agreement ("Grant Agreement") the City is required to enter into subcontracts with organizations that provide emergency housing and rapid re-housing assistance to eligible residents of the City who are homeless or at risk of homelessness, and the City has selected Organization as a sub-recipient of grant funds; and

WHEREAS, City and Organization entered into Contract No. 33326 whereby Organization agreed to perform these services and provide to the City the information and supporting documentation required in this Contract;

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the terms and conditions contained in the Contract and this Amendment, the parties agree as follows:

Section 3 of Contract No. 33326 is amended to read as follows:

"Section 3. The terms of this Contract shall commence at midnight on October 1, 2013, and, unless sooner terminated as provided herein, shall terminate at September 30, 2015."
