

FIRST AMENDMENT TO AGREEMENT NO. 35751

35751

THIS FIRST AMENDMENT TO AGREEMENT NO. 35751 is made and entered, in duplicate, as of January 27, 2022, for reference purposes only, pursuant to Resolution No. RES-20-0144, adopted by the City Council of the City of Long Beach at its meeting on November 17, 2020, by and between SYSTEM INNOVATORS, a division of N. HARRIS COMPUTER CORPORATION, a Canada corporation ("Consultant"), with a place of business at 9000 Southside Blvd., Bldg. 700, Suite 7200, Jacksonville, Florida 32256, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35751 (the "Agreement") whereby Consultant agreed to provide software maintenance and support services for the City's cashiering system; and

WHEREAS, the Parties desire to clarify the annual authority amount by including the contingency amount;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an annual amount of One Hundred Five Thousand Dollars (\$105,000), with a 20 percent (20%) contingency of Twenty-One Thousand Dollars (\$21,000), for a total annual contract amount not to exceed One Hundred Twenty-Six Thousand Dollars (\$126,000), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35751 are ratified and confirmed and shall remain in full force and effect.

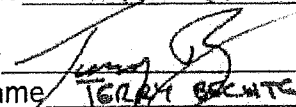

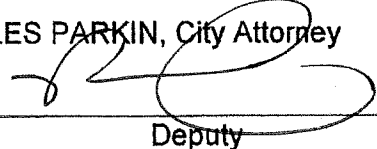
