acquisition of the office supplies as well as provide considerable cost benefits to the City;

Section 2. The City Manager of the City is hereby authorized to enter an

1 agreement with Office Depot, Inc., to purchase office supplies of substantially the same 2 type and kind purchased by the Regional 4 Education Service Center through the 3 Purchasing Cooperative Network pursuant to the TCPN Contract except as modified by mutual agreement of the City and Office Depot, Inc., and the purchase by the City shall 4 be on the same terms and conditions afforded to the Regional 4 Education Service 5 Center through the Purchasing Cooperative Network in an annual amount not to exceed 6 7 One Million Two Hundred Thousand Dollars (\$1,200,000) including tax and shipping, for a period of two (2) years, with the option of renewing for three (3) additional one-year 8 9 periods.

Section 3. This resolution shall take effect immediately upon its adoption
by the City Council, and the City Clerk shall certify the vote adopting this resolution.
