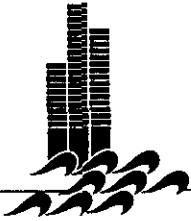

In response to your request for a recommendation regarding the above named permit application for Entertainment Without Dancing, the Police Department recommends **approval**, subject to the following fifteen (15) conditions of operation:

**CONDITIONS OF OPERATION**

- 1) The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- 2) Due to the proximity of residences, entertainment activities shall be restricted to no later than 12 midnight Sunday through Thursday nights and 1:30 a.m. on Friday and Saturday nights.
- 3) Unless separately applied for, reviewed and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC shall be conducted on the permitted premises.
- 4) The door(s) or windows shall be kept closed at all times during any entertainment activity described in the application, except in cases of emergency and to permit deliveries. Said door(s) are not to consist solely of a screen or ventilated security door.
- 5) No sound shall be audible from the exterior of the premises in any direction.
- 6) The permittee shall provide a minimum of one (1) uniformed security guard during all times that the entertainment activities are being conducted for crowds up to one hundred people. The security guard shall be charged with monitoring the patrons and preventing violation of any ABC laws and ordinances. Uniformed security guard means, "security guards must be identifiable as Fern's Cocktails employees." Should the permittee's operations give rise to a substantial increase in complaints/calls for service, the permittee shall increase security as directed by the Chief of Police.

- 7) Smoking shall not be allowed inside Fern's Cocktails at any time. "No smoking" signs shall be posted in conspicuous places inside the club and at the entrance to the business. (LBMC Chapter 8.68)
- 8) Current occupancy loads shall be posted at all times, and the licensee shall have an effective system to keep count of the number of occupants present at any given time. (LBMC section 18.48.320)
- 9) Fern's Cocktails, its promoters, or agents, shall not distribute any advertising matter in or upon any public property, or in or on any vehicle in any such place in the City. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter.
- 10) Fern's Cocktails shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside the rear door and parking lot area at all times open for business. This should be done by use of security guards and signage indicating words to the effect of, "Please respect our neighbors."
- 11) At the end of each night, Fern's Cocktails shall ensure that exiting patrons walk directly to their vehicles and not loiter in the immediate area, including the parking lot to the rear of the business and the parking lot across the street at 1253 E. 4<sup>th</sup> Street.
- 12) The permittee shall not hire promoters with the intent to advertise/promote or hold any entertainment activities consistent with nightclub entertainment.
- 13) The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.
- 14) If any noise, disturbance complaints, or trash left in the parking lot and surrounding area of the business can be attributed to the operation of said business, the Police Department can determine and impose requirements for security officer presence to routinely police and handle these problems.
- 15) The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances and stated conditions.
