FIRST AMENDMENT TO CONTRACT NO. 32641 32641

THIS FIRST AMENDMENT TO CONTRACT NO. 32641 is made and entered, in duplicate, as of November 19, 2015 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 10, 2015, by and between LONG BEACH COMMUNITY COLLEGE DISTRICT, a public education entity ("Contractor") with offices located at 4901 E. Carson Street, Long Beach, California 90808 and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network ("Pacific Gateway").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with training and educational support to Pacific Gateway participants; and

WHEREAS, the parties entered Contract No. 32641 whereby Contractor agreed to provide such services; and

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract and in this First Amendment, the parties agree as follows:

- 1. Section 2 of Contract No. 32641 is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Contract ("Term") shall be deemed to have commenced as of November 7, 2011, and unless sooner terminated pursuant to the provisions hereof, shall terminate on June 30, 2016. Either of the parties hereto shall have the right to terminate this Contract in its entirety at any time during the Term for any or no reason whatsoever by giving fifteen (15) days prior written notice of termination to the other party. City shall have the additional right to cancel any part of this Contract at any time during the Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to the Contractor.

Notwithstanding the foregoing, the City shall have the right to terminate and cancel this Contract without notice, in its sole discretion, if the actions or non-action of Contractor subjects the City to liability, legal obligations or program operation obligations beyond the liability and obligations under the Contract Documents. If this Contract is terminated prior to the expiration of the Term, Contractor shall be reimbursed for all eligible program allowable costs which have been accrued but not paid through the effective date of termination. Contractor agrees to accept such amount, plus all amounts previously paid, as full payment and satisfaction of all obligations of City to Contractor."

2. Except as expressly amended in this First Amendment, all terms and conditions in Contract No. 32641 are ratified and confirmed and shall remain in full force and effect.

I. PROGRAM SUMMARY:

The H-1B Health Sector Training Project with LBCCD will provide the following:

- Incumbent Worker Training (31 Participants)
 - Advanced Directive Liaisons = 4 participants
 - ER Techs Phlebotomy = 27 participants
- Academic Counseling (20 Participants)
- Non-Incumbent Worker Training (20 Participants)

II. FUNDING:

VI. CONTINUATION OF CONTRACT:

Continuation of this contract is contingent upon the satisfactory achievement of the standards and goals of this agreement as determined by Pacific Gateway and/or availability of H-1B funds from the Department of Labor.

VII. LETTER OF MODIFICATION:

All requests for contract modifications must be in writing and include detailed justification for such modifications. Pacific Gateway may initiate a letter of modification at any time during the contractual term with written concurrence from LBCCD.
