1 FIRST AMENDMENT TO AGREEMENT NO. 29891

3 THIS FIRST AMENDMENT is made and entered, in duplicate, as of July  
4 17, 2007 for reference purposes only, pursuant to a minute order adopted by the City  
5 Council of the City of Long Beach at its meeting on August 14, 2007, by and between M.  
6 ARTHUR GENSLER JR. & ASSOCIATES, INC., a California corporation, with a place of  
7 business at 2500 Broadway, Suite 300, Santa Monica, California 90404 ("Consultant"),  
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to  
10 be performed in connection with The Schroeder Hall U.S. Army Reserve Center Project  
11 ("Project"); and

12 WHEREAS, City selected Consultant in accordance with City's  
13 administrative procedures and City determined that Consultant and its employees are  
14 qualified, licensed, if so required, and experienced in performing the specialized services;  
15 and

16 WHEREAS, City and Consultant entered Agreement No. 29891 on  
17 December 14, 2006 for Consultant to perform specialized services, and now City and  
18 Consultant desire to extend the term of the Agreement;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
20 conditions in this Agreement, the parties agree as follows:

21 1. Section 2 of Agreement No. 29891 is deleted in its entirety and  
22 amended to read as follows:

23 "2. TERM. The term of this Agreement shall commence on June 15, 2007  
24 and terminate on December 15, 2007, unless sooner terminated as provided in this  
25 Agreement, or unless the services or the Project is completed sooner."

26 2. Except as expressly amended herein, all of the terms and conditions of  
27 Agreement No. 29891 are ratified and confirmed and shall remain in full force and effect.




