3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH CONFIRMING, READOPTING AND
5 AMENDING FILING FEES FOR PROCESSING VARIOUS
6 LAND DEVELOPMENT ACTIVITIES THROUGH THE
7 DEPARTMENT OF PUBLIC WORKS AND RESCINDING
8 RESOLUTION NO. C-25064

10 WHEREAS, on June 11, 1991, the City Council of the City of Long Beach
11 adopted Resolution No. C-25064 establishing fees for the processing of developer-
12 related activities and for processing permits by the Director of Public Works; and

13 WHEREAS, it is necessary to maintain fees at a level sufficient to recover
14 the costs of processing various land development activities through the Department of
15 Public Works; and

16 WHEREAS, the fees set forth in this resolution have not been revised
17 since June 11, 1991;

18 NOW, THEREFORE, the City Council of the City of Long Beach resolves
19 as follows:

20 Section 1. That existing fees for processing of land development-related
21 activities by the Department of Public Works shall be as follows:

25 **C. Records Search and Records Copying**

26 For providing staff assistance in the area of records search and records
27 copying, the fee shall be as determined in accordance with the Fee Schedule on file in
28 the Office of the City Engineer. Fees for such service shall not be applicable where

1 costs are recovered under other rules, regulations, resolutions, or ordinances. On or
2 before the first of August of each year, the City Engineer shall review and adjust the
3 Fee Schedule as necessary to maintain fees at a level sufficient to recover related
4 costs.

14 Sec. 2. Resolution No. C-25064 is hereby rescinded.

15 Sec. 3. The purpose of the fees herein imposed is to recover for the City
16 its costs of administering and providing the service for which the fee is levied. Such fee
17 or fees do not exceed the reasonable cost of providing services necessary to the
18 activity for which the fee is charged and is not levied for unrelated revenue purposes.

19 Sec. 4. Constitutionality, Severability. If any section, subsection,
20 sentence, clause or phrase of this Resolution is for any reason held to be invalid or
21 unconstitutional by the decision of any court of competent jurisdiction, such decision
22 shall not affect the validity of the remaining portions of the Resolution. The City Council
23 hereby declares that it would have passed this Resolution and each section, sub-
24 section, sentence, clause and phrase hereof, irrespective of the fact that any one or
25 more of the sections, sub-sections, sentences, clauses or phrases hereof be declared
26 invalid or unconstitutional. Additionally, the determination of an unconstitutional or
27 invalid section, subsection, clause or phrase shall have the effect of reviving the prior
28 section, subsection, sentence, clause, or phrase as previously set forth in Resolution


3 Sec. 5. This resolution shall take effect immediately upon its adoption by
