4                   THIS SECOND AMENDMENT TO WORKERS' COMPENSATION MEDICAL  
5 PROVIDER NETWORK SERVICING AGREEMENT NO. 35505 is made and entered, in  
6 duplicate, as of February 2, 2022, for reference purposes only, pursuant to a minute order  
7 adopted by the City Council of the City of Long Beach at its meeting on May 21, 2020, by  
8 and between MEDEX HEALTHCARE, INC., a California corporation ("Medex"), with  
9 principal offices located at 1201 Dove Street, Suite 300, Newport Beach, California 92660,  
10 and the CITY OF LONG BEACH, a municipal corporation ("City").

11                   WHEREAS, City and Medex (the "Parties") entered into Agreement No.  
12 35505 (the "Agreement") for Medical Provider Network (MPN) services; and

13                   WHEREAS, the Parties entered into a First Amendment to the Agreement to  
14 administratively align the authorized term; and

15                   WHEREAS, the Parties desire to extend the term one (1) additional one-year  
16 period;

17                   NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
18 conditions herein contained, the Parties agree as follows:

19                   1.       Section 2 of the Agreement is hereby amended to read as follows:

20                   "2.       This Agreement shall begin on January 1, 2020, and shall terminate  
21 at 11:59 p.m. on December 31, 2022 (both days inclusive), unless terminated earlier in  
22 accordance with the termination provisions provided in the Agreement. By mutual  
23 agreement and amendment of this Agreement, the Parties may extend the term for two (2)  
24 separate, consecutive periods of one (1) year each."


25                   2.       Except as expressly modified herein, all of the terms and conditions  
26 contained in Agreement No. 35505 are ratified and confirmed and shall remain in full force  
27 and effect.
