RECOMMENDATION:

Authorize the City Manager to execute an agreement and subsequent amendments with Los Angeles County Children and Families First - Proposition 10 Commission to implement the Best Babies Collaborative Program for an amount of \$280,454; execute subcontracts in the amount of \$62,470 and subsequent amendments with the listed subcontract agencies for outreach and health education; execute an amendment to the planning grant to extend the due date for plan materials; and increase appropriations in the Health Fund (SR 130) in the Department of Health and Human Services (HE) by \$280.454 for the period of October 1. 2005 to June 30, 2006. (Districts 1, 6, 7 and 9)

DISCUSSION

On May 24, 2005, the City Council approved a four-month planning grant for the Best Babies Collaborative Program (BBC) funded by the Los Angeles County Children and Families First -Proposition 10 Commission (First 5 L.A.). The purpose of the planning grant was to develop the work plan and the collaborative activities for the implementation period of the program. First 5 L.A. has subsequently awarded \$280,454 for the period October 1, 2005 through June 30, 2006 to the City of Long Beach, through the Department of Health and Human Services (DHHS) as the lead agency, to commence implementation of the three-year program (October 2005 – July 2008) for the Long Beach-Wilmington Best Babies Collaborative (Collaborative). The DHHS will provide and coordinate perinatal services targeting high-risk women residing in the First 5's targeted zip code areas of 90802, 90805, 90806, 90813, and in the 90744 Wilmington zip code.

The DHHS will work with local service providers, community-based agencies and healthcare organizations to develop and coordinate a comprehensive network of providers and resources to improve pregnancy outcomes for women in these target areas. The Collaborative will link existing resources and strengthen the capacity of existing organizations already providing perinatal services in these areas.

Additional annual renewals will be awarded upon the satisfactory completion of the stated objectives of each year's work plan. Of the total grant amount, a total of \$68,275 is being dedicated to program areas, of which a total of \$62,470 is being requested to be subcontracted to community agencies. These funds will be used specifically for outreach, health education, medical and case-management activities with the following community-based collaborative agencies that were selected based on their ability to serve special population groups:
