## AMENDMENT NO. ONE TO CONTRACT NO. 30405

**RE: Renewal No. One of Contract No. 30405 (PA-00108) to Furnish and Deliver Miscellaneous Hand & Power Tools to the City of Long Beach (BPLB08000017)**

This Amendment to Contract No. 30405 is made and entered as of September 4, 2008 by and between the CITY OF LONG BEACH, a municipal corporation, and W.W. Grainger Inc.(Contractor)


Contract No. 30405 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 1. The term is extended to December 1, 2009.
- 2. \$50,000 has been added to the 1<sup>st</sup> renewal term for a total ("not to exceed") \$100,000.
- 3. <sup>Discounts</sup> Prices during this period shall remain firm. as represented in Exhibit C. (see attached)
- 4. The price for certain items shall be increased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 5. The price for certain items shall be decreased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 6. The discount offered to the City is increased by \_\_\_\_ %.
- 7. The items or locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby deleted from the Contract.
- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.
- 9. Current permits, licenses, insurance and other required information are enclosed as Addendum No. 1.

Except as expressly amended above, all terms and conditions in this Contract are ratified and confirmed and remain in full force and effect. Executed with all formalities required by law as of the date first stated above.



DISCOUNTS & PRICING**

**DISCOUNT PROGRAMS**

**General Catalog Discount of 10%:**

This Program offers the Commonwealth a primary pricing program that guarantees a ten percent (10%) firm discount for the term of the contract. The ten percent (10%) discount will be applied to the "each" price in the most recent edition of the Grainger catalog or the "each" price found at Grainger.com. Individual "each" prices are subject to change without notice. Prices, in all cases, are those in effect at time of purchase, which can be obtained at Grainger.com. The ten percent (10%) discount will remain firm for the term of the award.

**Motors Discount Program\*:**

This Program offers the City a discount of twenty-eight percent (28%) from the Grainger Catalog "each" price on specific electric motor and power transmission ("Motors") Products. Discount is firm for the term of the Contract.

**Air Filter Discount Program\*:**

This Program offers the City a discount of forty-five percent (45%) from the Grainger Catalog "each" price on specific air filter ("Air Filters") Products. Discount is firm for the term of the Contract.

**Cleaning Supplies Discount Program\*:**

This Program offers the City a discount of eighteen percent (18%) from the Grainger Catalog "each" price on specific Cleaning supplies ("Cleaning Supplies") Products. Discount is firm for the term of the Contract.

**Hand and Power Tools Discount Program\*:**

This Program offers the City the following discounts off of the manufacturer's current list price on select items except as otherwise provided:
