1 FIFTH AMENDMENT TO AGREEMENT NO. 30332

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 30332 is made and
4 entered, in duplicate, as of September 15, 2016 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting held
6 on July 10, 2007, by and between KONICA MINOLTA BUSINESS SOLUTIONS, U.S.A.,
7 Inc., a New York corporation, with a place of business at 879 W. 190th Street, #200,
8 Gardena, California 90248 ("Konica"), and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with providing hardware, software and maintenance services; and

12 WHEREAS, the parties entered into Agreement No. 30332 wherein Konica
13 agreed to provide these services; and

14 WHEREAS, the parties now desire to extend the term;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions in the Agreement, the parties agree as follows:

17 1. Section 3 of Agreement No. 30332 is hereby deleted in its entirety and
18 amended and restated to read as follows:

19 "3. TERM. The term of this Agreement shall commence on September
20 16, 2015 and shall terminate on September 15, 2017. The term of this Agreement may be
21 extended by the execution of a written amendment by the City Manager of City. Each
22 business transaction may have a different term and that term will be identified on a
23 Transaction Document. This Agreement may be terminated by either party upon thirty (30)
24 days written notice without penalty or further obligation after City has paid for services
25 rendered through the date of termination."


26 2. Except as set forth in this Fifth Amendment, all terms and conditions
27 of Agreement No. 30332 are ratified and confirmed and shall remain in full force and effect.


