3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE A CONTRACT WITH  
6 SOUTHERN CALIFORNIA FLEET SERVICES, INC.,  
7 WITHOUT ADVERTISING FOR BIDS, TO PROVIDE  
8 SEAGRAVE FIRE APPARATUS PARTS AND SERVICE ON  
9 AN AS-NEEDED BASIS FOR A PERIOD OF TWO YEARS  
10 WITH THE OPTION TO RENEW FOR TWO ADDITIONAL  
11 ONE-YEAR PERIODS IN AN ANNUAL AMOUNT NOT TO  
12 EXCEED \$220,000

13  
14 WHEREAS, the Fleet Services Bureau performs preventive maintenance  
15 and repairs to 31 active Seagrave fire truck units as part of the City's fleet maintenance  
16 program; and

17 WHEREAS, Seagrave Fire Apparatus, LLC, of Clintonville, WI, is the  
18 original manufacturer of Seagrave fire equipment; and

19 WHEREAS, Southern California Fleet Services, Inc., has been designated  
20 by Seagrave Fire Apparatus, LLC, as the authorized dealer and service center for  
21 Seagrave fire apparatus for the Southern California region; and

22 WHEREAS, no useful purpose would be served by advertising for bids, and  
23 to do so would constitute an unproductive use of time and an unnecessary expenditure of  
24 public funds; and

25 WHEREAS, therefore, the Department of Financial Management would like  
26 to enter into an annual contract for parts and service from Southern California Fleet  
27 Services, Inc., on an as-needed basis;

28 NOW, THEREFORE, the City Council of the City of Long Beach resolves as

1 follows:

2 Section 1. The City Manager is hereby authorized to enter into a  
3 contract, without advertising for bids, with Southern California Fleet Services, Inc., to  
4 provide Seagrave fire apparatus parts and service on an as-needed basis by the City for  
5 a period of two (2) years in an annual amount not to exceed Two Hundred Twenty  
6 Thousand Dollars (\$220,000). The parties may, by mutual agreement, extend the term  
7 for two (2) additional periods of one (1) year each.

8 Section 2. This resolution shall take effect immediately upon its adoption  
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

10 I hereby certify that the foregoing resolution was adopted by the City
