3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH APPROVING THE APPLICATION  
5 WITH THE CALIFORNIA EMERGENCY MANAGEMENT  
6 AGENCY FOR THE HOMELAND SECURITY GRANT  
7 PROGRAM FUNDING.

9 The City Council of the City of Long Beach resolves as follows:

10  
11 WHEREAS, the California Emergency Management Agency has recently  
12 awarded the City of Long Beach Federal Emergency Management Agency Homeland  
13 Security Grant Program funds in the amount of One Hundred Five Thousand Dollars  
14 (\$105,000.00); and

15 WHEREAS, these funds have become available due to reallocation of  
16 unspent federal grants; and

18 WHEREAS, under this grant, the Long Beach Fire Department will  
19 purchase hazardous materials response equipment to increase the capabilities to  
20 respond to any chemical, biological, radiological, nuclear or explosive event. The use of  
21 these funds will enable continued and improved focus on enabling first responders to  
22 protect the City's assets and resources. The new equipment will be utilized to monitor  
23 and detect weapons of mass destruction agents and chemicals; and

24 WHEREAS, in order for the City of Long Beach to receive and expend grant  
25 funding, the California Emergency Management Agency requires the City Council to  
26 adopt a resolution establishing an authorizing agent to execute all necessary documents  
27 and amendments for the purpose of obtaining federal financial assistance by the Federal

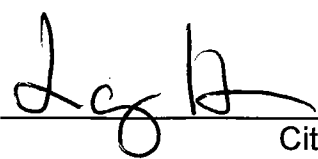
Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
