3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33652 is made and  
4 entered, in duplicate, as of September 12, 2016, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 November 18, 2014, by and between D. WOOLLEY & ASSOCIATES, INC., a California  
7 corporation ("Consultant"), with a place of business at 2832 Walnut Avenue, Suite A,  
8 Tustin, California 92780, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with as-needed surveying services; and

11 WHEREAS, City and Consultant entered into Agreement No. 33652 (the  
12 "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, City and Consultant wish to exercise their first option to extend  
14 the term;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
16 conditions herein contained, the parties agree as follows:

17 1. Section 2 of the Agreement is hereby amended to read as follows:

18 "2. TERM. The term of this Agreement shall commence at midnight on  
19 December 31, 2014, and shall terminate at 11:59 p.m. on January 1, 2018, unless sooner  
20 terminated as provided in this Agreement, or unless the services or the Project is  
21 completed sooner. The parties have the option to renew this Agreement for one (1)  
22 additional one-year period."

23 2. Except as expressly modified herein, all of the terms and conditions  
24 contained in Agreement No. 33652 are ratified and confirmed and shall remain in full force  
25 and effect.

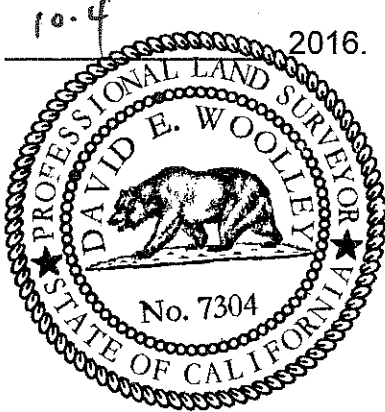
