3 THIS SECOND AMENDMENT TO CONTRACT NO. 27893 is made and entered,  
4 in duplicate, as of March 18, 2006, for reference purposes only, pursuant to a minute order  
5 adopted by the City Council of the City of Long Beach at its meeting on April 4, 2006, by and  
6 between CATHOLIC HEALTHCARE WEST, a California nonprofit public benefit corporation,  
7 dba St. Mary Medical Center ("Hospital") and the CITY OF LONG BEACH, a municipal  
8 corporation ("City").

9 WHEREAS, the parties entered Contract No. 27893 and certain amendments  
10 thereto (as amended, the "Contract"); and

11 WHEREAS, the parties desire to amend the terms of the Contract;

12 NOW, THEREFORE, in consideration of the mutual terms and conditions in the  
13 Contract, the parties agree as follows:

14 1. The parties hereby amend the first sentence of Section 8 of the Contract to  
15 read as follows:

16 "Notwithstanding the initial commencement and expiration dates of this Agreement, the  
17 term of this Agreement shall be renewed effective March 18, 2006 ("Renewal Effective  
18 Date"). This Agreement shall continue for a term of two (2) years from the Renewal  
19 Effective Date, unless sooner terminated as otherwise provided herein."

20 2. Except as expressly amended herein, all of the terms and conditions of the  
21 Contract are ratified and confirmed and shall remain in full force and effect.
