FIRST AMENDMENT TO AGREEMENT NO. 35413

35413

THIS FIRST AMENDMENT TO AGREEMENT NO. 35413 is made and entered, as of July 7, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 17, 2019, by and between EIDIM GROUP, INC. DBA EIDIM AV TECHNOLOGY, a California corporation ("Contractor"), with a place of business at 6905 Oslo Circle, Suite J, Buena Park, California 90621, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35413 (the "Agreement") whereby Contractor agreed to furnish and install Assistive Learning Systems in existing library community rooms and other public facilities in the amount of Two Hundred Ninety-Nine Thousand Seven Hundred Ninety-Six Dollars (\$299,796) with a thirty-five percent (35%) contingency in the amount of One Hundred Four Thousand Nine Hundred Twenty-Nine Dollars (\$104,929) for a total amount not to exceed Four Hundred Four Thousand Seven Hundred Twenty-Five Dollars (\$404,725) for a period of two (2) years, with the option to extend for three additional one-year periods; and

WHEREAS, the Parties desire to utilize two of the one-year extensions to extend the term to September 16, 2023;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. **TERM.** The term of this Agreement shall commence at midnight on September 17, 2019, and shall terminate at 11:59 p.m. on September 16, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for one (1) additional one-year period, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35413 are ratified and confirmed and shall remain in full force
