3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30263 is made and
4 entered, in duplicate, as of February 1, 2010 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 September 18, 2007, by and between URS CORPORATION doing business in California
7 as URS CORPORATION AMERICAS, a Nevada corporation ("Consultant"), with a place
8 of business at 2020 East First Street, Suite 400, Santa Ana, California 92705, and the
9 CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, the parties entered Agreement No. 30263 whereby Consultant
11 agreed to provide specialized services requiring unique skills to be performed in
12 connection with Preparing Project Initiation Document (PID) and Project Report and
13 Environmental Document (PAVED) for the Realignment of the Shoemaker Bridge and
14 Ramps ("Project"); and

15 WHEREAS, the parties desire to extend the term of the Agreement;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions in
17 Agreement No. 30263 and herein, the parties agree as follows:

18 1. Section 2 of Agreement No. 30263 is hereby amended to read as
19 follows:

20 "2. TERM. The initial term of this Agreement shall commence at
21 midnight on September 18, 2007, and shall terminate at 11:59 p.m. on December 31,
22 2009. The extended term of this Agreement shall commence at midnight on January 1,
23 2010, and shall terminate at 11:59 p.m. on December 31, 2011, unless sooner terminated
24 as provided in this Agreement, or unless the services or the Project is completed sooner."

25 2. Except as expressly amended herein, all terms and conditions in
26 Agreement No. 30263 are ratified and confirmed and shall remain in full force and effect.

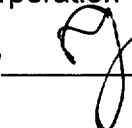

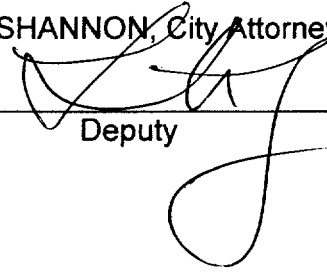
