## THIRD AMENDMENT TO LEASE NO. 16419

## 

THIS THIRD AMENDMENT TO LEASE NO. 16419 ("Third Amendment") is made and entered, in duplicate as of September 24, 2008, for reference purposes only, pursuant to an order of the City Council of the City of Long Beach at its meeting held on September 23, 2008, by and between CATALINA FLYING BOATS, INC., a California corporation ("Tenant"), and the CITY OF LONG BEACH, a California municipal corporation ("Landlord").

WHEREAS, the Landlord on August 18, 1992 authorized that certain Fixed Base Operation Lease No. 16419 with Tenant dated May 13, 1992 (as amended, the "Lease"), which was later amended by that Amendment to Fixed Base Operation Lease dated June 25, 1993, and further amended by that certain Second Amendment to Fixed Base Operations Lease dated March 1, 2000. Pursuant to the Lease, Tenant leases approximately 1.241 acres of land as more particularly shown in the Lease ("Premises"); and

WHEREAS, the term of the Lease expires on May 12, 2017; and

WHEREAS, the parties wish to extend the term of the Lease and otherwise amend certain terms and conditions of the Lease as described in this Amendment;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- Term. The term of this Lease shall be extended beginning May 13,
  and shall terminate at midnight on May 31, 2048.
- 2. Additional Rent. Beginning on October 1, 2008 and continuing monthly thereafter for the term of the Lease as extended by this Third Amendment, Tenant shall pay to Landlord monthly additional rent payments in the amount of Six Hundred Twelve and 24/100 Dollars (\$612.24). The additional rent payments reflect a lease extension fee of \$87,951 amortized at eight percent (8%) over the remaining term

of the Lease. The additional rent payments made under this Paragraph 2 shall be in addition to the rent to be paid under Section 7 of the Lease and in addition to all other amounts which may otherwise be payable by Tenant under the Lease. 3. Except as amended herein, the terms and conditions of the Lease are ratified and confirmed and shall remain unchanged and in full force and effect.
