Subject: Senate Bill 696 (Wright)

Dear Mayor Foster:

As you may be aware, due to a recent state court ruling regarding the California Environmental Quality Act (CEQA), the South Coast Air Quality Management District (AQMD) has been forced to stop issuing permits relying on the District's internal offsets accounts. This ruling impacts over 1,100 permit applications, as well as permits we issued as far back as September 2006, involving projects such as essential public services, sewage treatment plants, hospitals, schools, fire and police stations, and landfill gas-to-energy projects. In addition, small businesses such as gas stations, dry cleaners, auto body shops, printers, and food manufacturers are unable to expand or open their doors because they cannot locate or afford credits on the open market (Attachment 1).

There are over 30 City of Long Beach (city government) projects potentially affected by the permit moratorium at AQMD. This is causing significant hardship to permit holders and applicants. For an expeditious solution to this critical issue, AQMD is sponsoring state legislation, SB 696, by Senator Rod Wright, which will provide a limited CEQA exemption for implementation of specific AQMD rules creating or providing offsets from AQMD's internal bank. It is important to note that proposed projects will still be subjected to CEQA review by the lead agency, as before, and safeguards are proposed in the legislation to limit access to AQMD's internal offsets bank by power producers.

Re: SB 696 - SUPPORT

Dear Senator Wright,

On behalf of the California State Council of Laborers, I write in strong SUPPORT of your bill, SB 686.

Due to a recent court decision ,South Coast Air Quality Management District (SCQMD) is unable to issue over a thousand pending permits that are either exempt from offset requirements, or qualified to use offset credits from the district's priority reserve and is required to set aside thousands of permits already issued. SB 696 is necessary so the district can issue permits in an expeditious manner and to validate previously issued permits called into question by the Superior Court's decision.

If action is not taken to correct this situation, projects will be stopped from going forward or frozen in place, representing significant losses to the economy, as well as numerous well-paying jobs. The impact of approved projects not going forward will dramatically impede any economic recovery in Southern California and contribute to another state deficit as a result of lower tax revenues.

Affected projects include equipment replacement to reduce air emissions, plus projects for essential public services such as hospitals, schools, landfills, sewage treatment plants, renewable energy projects, and small sources, including small businesses that are unable to locate or afford credits on the open market. The Superior Courts decision also prohibits the district from issuing air credits from its priority reserve to thermal power plants that are needed to meet the current and future projected electricity needs of the region and to prevent blackouts during peak demand periods.

#### Re: SB 696 (Wright) - Support

Dear Senator Padilla:

The California Hospital Association (CHA), which represents nearly 450 hospitals and healthcare systems, supports SB 696, authored by Senator Roderick D. Wright because it is needed to allow the South Coast Air Quality Management District (SCAQMD) to issue needed permits to hospitals for diesel backup generators and boilers to offset emissions as required by the Clean Air Act.

Approximately 50 percent of California hospitals are losing money on operations. Hospitals may not be able to purchase private credits to obtain permits and, if they are available, the cost of credits may be prohibitive.

As required by the State Building Code, State Licensing requirements, federal Medicare Conditions of Participation and The Joint Commission Standards, general acute care inpatient hospitals <u>must</u> remain operational 24 hours a day, every day of the year. Therefore, it is essential that hospitals have the ability to add and replace diesel backup generators and boilers, as needed, to ensure 24 hour care for their patients and service area.

In addition, California hospital buildings are now required to meet seismic standards under the Hospital Seismic Mandate, SB 1953 (Chapter 740, Statutes of 1994). By January 1, 2013 (or January 1, 2015 if an extension has been granted), every hospital building must meet specific construction standards that at minimum keep these structures standing after a major seismic event. By January 1, 2030, the law requires all hospital buildings to comply with standards intended to keep these buildings operational following a major seismic event. The SCAQMD region has 140 hospitals at this time with at least one building that must retrofit, rebuild or close by 2013/2015.

The complex hospital construction process can take many years; therefore, a number of hospitals throughout California are in the process of purchasing and installing diesel backup generators and boilers at this time, including twenty-five hospitals in the SCAQMD region.
