

1 . SECOND AMENDMENT TO CONTRACT NO. 32168

3 THIS SECOND AMENDMENT TO CONTRACT NO. 32168 is made and
4 entered, in duplicate, as of November 21, 2012 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting held
6 on November 20, 2012, by and between BITECH CONSTRUCTION COMPANY INC., a
7 California corporation ("Contractor"), whose address is 5241 Lincoln Avenue, Suite A-6,
8 Cypress, California 90630, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, pursuant to a "Notice Inviting Bids for the Annual Contract for
11 Concrete Repairs and Related Improvements in the City of Long Beach, California,"
12 dated December 1, 2010, and published by City, bids were received, publicly opened and
13 declared on the date specified in said Notice; and

14 WHEREAS, the parties entered Contract No. 32168 for the work described
15 in the bid documents; and

16 WHEREAS, the parties desire to extend the term and add \$3,000,000 for a
17 total not to exceed amount of \$7,000,000;

18 NOW, THEREFORE, in consideration of the mutual terms and conditions in
19 the Contract and in this Second Amendment, the parties agree as follows:

20 1. Section 4 of Contract No. 32168 is hereby amended to read as
21 follows:

22 "4. TIME FOR CONTRACT. The term of this Contract shall commence
23 at midnight on April 20, 2011, and shall terminate at 11:59 p.m. on December 31, 2013,
24 unless sooner terminated as provided in this Contract, or unless the services or the
25 Project is completed sooner."


26 2. Except as expressly amended in this Second Amendment, all terms


