

3 A RESOLUTION OF INTENTION TO VACATE THE  
4 WESTERLY 613 FEET OF SIXTY-EIGHTH STREET WEST  
5 OF PARAMOUNT BOULEVARD, IN THE CITY OF LONG  
6 BEACH, COUNTY OF LOS ANGELES, STATE OF  
7 CALIFORNIA, PURSUANT TO THE PUBLIC STREET,  
8 HIGHWAYS AND SERVICE EASEMENTS LAW (DIVISION 9,  
9 PART 3, CALIFORNIA STREETS AND HIGHWAYS CODE);  
10 FIXING A TIME AND PLACE FOR HEARING ALL PERSONS  
11 INTERESTED IN OR OBJECTING TO THE PROPOSED  
12 VACATION

13  
14 The City Council of the City of Long Beach resolves as follows:

15 Section 1. The City Council of the City of Long Beach hereby elects to  
16 proceed under Division 9, Part 3, Chapter 3, of the California Streets and Highways Code,  
17 as amended, generally known and referred as the "Public Street, Highways and Service  
18 Easements Law", and hereby declares its intention to vacate the westerly 613 feet of Sixty-  
19 Eighth Street west of Paramount Boulevard in the City of Long Beach, County of Los  
20 Angeles, State of California, described more particularly as follows:

21 Being that portion of 68<sup>th</sup> Street in the City of Long Beach,  
22 County of Los Angeles, State of California, As shown on Tract  
23 No. 23243 as recorded in Book 825, Pages 65 and 66 of  
24 Miscellaneous Records and Tract No. 30356 as recorded in  
25 Book 818, Page 53 of Miscellaneous Records, both of said  
County of Los Angeles, lying easterly of the easterly line of the  
Union Pacific R.R. Right-of-Way as shown on said Tract No.  
23243 and said Tract No. 30356, and lying westerly of the  
following described line:

26 Commencing at the centerline intersection of 68<sup>th</sup> Street and  
27 Paramount Boulevard as shown on said map of Tract No.  
28 23243; thence south 89°46'09" west 676.76 feet along the  
centerline of said 68<sup>th</sup> Street; thence south 00°13'51" east  
30.00 feet to a point on the northerly line of said lot 2, said  
northerly line also being the southerly line of said 68<sup>th</sup> Street,

1                   said point also being the **TRUE POINT OF BEGINNING**;  
2                   thence north 00°13'51" 60.00 feet to the northerly line of said  
3                   68<sup>th</sup> Street.

4                   Sec. 2. All of the foregoing real property is shown on the map or plan thereof,  
5                   attached hereto as Exhibit "A", and on file in the office of the City Clerk, which map or plan  
6                   is known and referred to as City of Long Beach Department of Public Works Vacation  
7                   Sketch No. 879V, said sketch showing the westerly 613 feet of Sixty-Eighth Street west of  
8                   Paramount Boulevard to be vacated by the City of Long Beach.

9                   Sec. 3. The City Council hereby fixes the 12th day of June 2007,  
10                  at the hour of 5:00 p.m., as the time and the City Council Chamber, Plaza Level  
11                  of the City Hall, 333 West Ocean Boulevard, in the City of Long Beach, California, as the  
12                  place for hearing all persons interested in or objecting to the proposed vacation.

13                  Sec. 4. The City Council hereby directs that notice of this street vacation be  
14                  posted conspicuously along the street to be vacated at least two (2) weeks before the date  
15                  set for hearing and in the manner provided by Section 8323 of the State Streets and  
16                  Highways Code.

17                  Sec. 5. This resolution shall take effect immediately upon its adoption by the  
18                  City Council, and the City Clerk shall certify the vote adopting this resolution.



