A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY TO PURCHASE TWO (2) STENCIL PAINT TRUCKS THROUGH THE PURCHASE ORDER BETWEEN THE CITY OF UKIAH AND LINE MASTER ENGINEERING

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase two (2) stencil paint trucks; and

WHEREAS, the City of Ukiah has a contract for the purchase of these stencil paint trucks from Line Master Engineering, Inc., Purchase Order No. 036800 ("Ukiah Purchase Order"); and

WHEREAS, City's participation in the Ukiah Purchase Order will facilitate acquisition of the stencil paint trucks as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Ukiah Purchase Order considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Line Master Engineering, Inc. to purchase two (2) stencil paint

1 trucks of substantially the same type and kind purchased by the City of Ukiah pursuant to  
2 the Ukiah Purchase Order except as modified by mutual agreement of the City of Long  
3 Beach and Line Master Engineering, Inc. and the purchase by the City of Long Beach shall  
4 be on the same terms and conditions afforded to the City of Ukiah in an amount not to  
5 exceed \$118,966.76 including tax, for a period extending until the warranty on the two (2)  
6 stencil paint trucks expires.

7 Sec. 3. This resolution shall take effect immediately on its adoption by the  
8 City Council, and the City Clerk shall certify the vote adopting this resolution.
