## SECOND AMENDMENT TO SUBCONTRACT NO. 28564

THIS SECOND AMENDMENT TO SUBCONTRACT NO. 28564 is made and entered, in duplicate, as of August 10, 2005 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on August 24, 2004, by and between BEING ALIVE LONG BEACH, a California nonprofit corporation, doing business as BALB, whose address is 500 East Fourth Street, Long Beach, California 90302 ("BALB") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City will receive monies from the State Department of Health Services for the 2006 HIV Education and Prevention Program Grant (the "State Contract"); and

WHEREAS, said Subcontract provided that it could be extended for an additional eight month period if certain conditions were met and those conditions have been met; and

WHEREAS, the parties desire to so extend said Subcontract and to amend it in certain respects;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained in said Subcontract and herein, the parties agree as follows:

1. Section 1 of Subcontract No. 28564 is hereby amended in its entirety to read as follows:

"Section 1. The original term of this Subcontract shall commence at midnight on November 1, 2004, and, unless sooner terminated as provided herein, shall terminate at 11:59 p.m. on June 30, 2006."

- 2. City shall pay BALB for such services not to exceed Eighty One Thousand, Six Hundred Dollars (\$81,600).
- Except as set forth in this Second Amendment to Subcontract No.
   28564, all terms and conditions of said Subcontract are ratified and confirmed and shall

remain in full force and effect.
