TENTH AMENDMENT TO AGREEMENT NO 34690

THIS TENTH AMENDMENT TO AGREEMENT NO. 34690 is made and entered, in duplicate, as of July 20, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 13, 2021, by and between THE CODE GROUP, INC. DBA VCA CODE, a California corporation ("Consultant"), with a place of business at 1845 West Orangewood Avenue, Suite 210, Orange, California 92868, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34690 (the "Agreement") whereby Consultant agreed to provide as-needed plan review and inspection services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$24,800 for a total not to exceed amount of \$59,800; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$118,800 for a total not to exceed amount of \$178,600; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$75,000 for a total not to exceed amount of \$253,600; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add \$136,900 for a total not to exceed amount of \$390,500; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to add \$55,000 for a total not to exceed amount of \$445,500 and extend the term to July 31, 2020; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to add \$304,500 for a total not to exceed amount of \$750,000; and

WHEREAS, the Parties entered into a Seventh Amendment to the Agreement to add \$80,000 for a total not to exceed amount of \$830,000; and

WHEREAS, the Parties entered into an Eighth Amendment to the Agreement

to add \$200,000 for a total not to exceed amount of \$1,030,000 and extend the term to July 31, 2021; and

WHEREAS, the Parties entered into a Ninth Amendment to the Agreement to add \$355,300 for a total not to exceed amount of \$1,385,300; and

WHEREAS, the Parties desire to add \$525,000 to the Agreement for a total not to exceed amount of \$1,910,300 and extend the term to October 31, 2021;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Nine Hundred Ten Thousand Three Hundred Dollars (\$1,910,300), at the rates or charges shown in Exhibit "B"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on August 1, 2017, and shall terminate at 11:59 p.m. on October 31, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- Except as expressly amended herein, all terms and conditions in Agreement No. 34690 are ratified and confirmed and shall remain in full force and effect.
