BACKGROUND OF THE SOCIAL SERVICES GRANT PROGRAM

The Social Services Grant Program was established in 1986 by the Long Beach City Council to encourage the development of innovative programs to address unmet and emerging social service needs of low-income Long Beach residents. The program also serves to supplement critical health and social services for underserved populations that are presently under-funded and/or inadequate in scope, including homeless people. The Social Services Grant Program incorporates City of Long Beach funds.

Grant proposals are reviewed by members of the Board of Health and Human Services, the Homeless Services Advisory Committee (HSAC), the Community Development Advisory Commission (CDAC) and the Long Beach Housing Development Corporation will also review proposals for homeless services. Funding recommendations are then made to the City Council. Qualified non-profit organizations interested in enhancing the delivery of health and social services to the Long Beach community are encouraged to submit applications in accordance with the guidelines in this announcement.

City of Long Beach Funds

Specific needs for health and human services for 2007-2008 were identified following a public hearing held by the Board of Health and Human Services. Based on the testimony received at the public hearing and a review of related information concerning social services resources and needs in the community, the following priority categories of service need have been established and are listed alphabetically:

- 1. Alcohol and Drug Abuse Treatment Services
- 2. Children, Youth, and Family Services
- 3. Family Violence and Sexual Abuse/Assault Services
- 4. Gang Violence Prevention Programs
- 5. Health and Mental Health Services
- 6. Homeless Services
- 7. Senior Citizen Services
- 8. Services for Persons with Disabilities
- 9. Supportive Services that Support Access to Affordable Housing

Emergency Shelter Grant Funds (ESG)

Specific needs for homeless services for 2007-2008 were identified following; testimony on needs of homeless persons provided to the Board of Health and Human Services at their hearing, to the Homeless Services Advisory Committee at their hearings, and through a review of related information concerning homeless services, resources and needs in the community.

The use of Emergency Shelter Grant (ESG) funds is restricted by federal regulations (24 CFR Part 576). The purpose of ESG is to improve the quality and number of emergency homeless shelters by funding emergency shelter and related social services. This program is designed to be the first step in a continuum of assistance to enable homeless individuals and families to move toward independent living as well as to prevent homelessness.

The primary objectives of the ESG program are in the areas of Operations, Essential Services, and Prevention Services for the homeless:

Operations:

- Help improve the quality or emergency shelters for the homeless;
- Assist agencies to meet the cost of operating shelters;

Essential Services:

 Assist agencies in providing essential social services linked to emergency housing; and

Prevention Services:

 Assist agencies with activities or programs designed to prevent the incidence of homelessness.

The ESG regulations define emergency shelter as any facility, the primary purpose of which is to provide temporary or transitional shelter for the homeless in general or for specific populations of the homeless.

Homeless prevention is defined as activities or programs designed to prevent the incidence of homelessness, including (but not limited to): (1) Short-term subsidies to defray rent and utility arrearages for families that have received eviction or utility termination notices; (2) Security deposits or first month's rent to permit a homeless family to move into its own apartment; (3) Mediation programs for landlord-tenant disputes; (4) Legal services programs for the representation of indigent tenants in eviction proceedings; (5) Payments to prevent foreclosure on a home; and (6) Other innovative programs and activities designed to prevent the incidence of homelessness.
