1 FIRST AMENDMENT TO AGREEMENT NO. 35246

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35246 is made and
4 entered, in duplicate, as of February 1, 2021, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 5, 2019, by and between WILLDAN ENGINEERING, a California corporation
7 ("Consultant"), with a place of business at 13191 Crossroads Parkway North, Suite 405,
8 Industry, California 91746, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 35246 (the "Agreement") whereby Consultant agreed to provide on-call environmental,
12 planning and affordable housing consultant services; and

13 WHEREAS, the Parties desire to add \$300,000 to the Agreement for a total
14 not to exceed amount of \$600,000 and extend the term one (1) additional one-year period;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the Parties agree as follows:

17 1. Section 1.A. of the Agreement is hereby amended to read as follows:

18 "A. Consultant shall furnish specialized services more particularly
19 described in Exhibit "A", attached to this Agreement and incorporated by this
20 reference, in accordance with the standards of the profession, and City shall pay for
21 these services in the manner described below, not to exceed Six Hundred Thousand
22 Dollars (\$600,000), at the rates or charges shown in Exhibit "B"."

23 2. Section 2 of the Agreement is hereby amended to read as follows:

24 "2. TERM. The term of this Agreement shall commence at midnight on
25 March 6, 2019, and shall terminate at 11:59 p.m. on March 5, 2022, unless sooner
26 terminated as provided in this Agreement, or unless the services or the Project is
27 completed sooner. The term may be extended for two (2) additional one-year periods, at
28 the discretion of the City Manager"
