RESOLUTION NO. RES-12-0062

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE UNLEADED AND DIESEL FUEL THROUGH THE AGREEMENT BETWEEN SADDLEBACK VALLEY UNIFIED SCHOOL DISTRICT AND MERRIMAC PETROLEUM, INC. DBA MERRIMAC ENERGY GROUP

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase unleaded and diesel fuel; and

WHEREAS, the Saddleback Valley Unified School District has an agreement, pursuant to Bid #11-04, for the purchase of unleaded and diesel fuel; and

WHEREAS, the City's participation in the Saddleback Valley Unified School District Agreement will facilitate acquisition of unleaded and diesel fuel as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Saddleback Valley Unified School District Agreement considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager of the City is hereby authorized to enter an

1 agreement with Merrimac Petroleum, Inc. dba Merrimac Energy Group to purchase  
2 unleaded and diesel fuel of substantially the same type and kind purchased by the  
3 Saddleback Valley Unified School District pursuant to the Saddleback Valley Unified  
4 School District Agreement except as modified by mutual agreement of the City and  
5 Merrimac Petroleum, Inc. dba Merrimac Energy Group, and the purchase by the City  
6 shall be on the same terms and conditions afforded to the Saddleback Valley Unified  
7 School District in an amount not to exceed \$5,500,000, including tax and shipping, for  
8 one year.

9 Section 3. This resolution shall take effect immediately upon its adoption  
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
