

1 SECOND AMENDMENT TO AGREEMENT NO. 33499

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 33499 is made and
4 entered, in duplicate, as of June 22, 2017, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting only June
6 13, 2017, by and between MLA GREEN, INC. DBA MIA LEHRER & ASSOCIATES, a
7 California corporation, with a place of business at 3780 Wilshire Blvd., Suite 250,
8 Los Angeles, California 90010 ("Consultant"), and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed landscape architectural services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
13 33499 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement to
15 extend the term and add \$250,000 for a total not to exceed amount of \$500,000; and

16 WHEREAS, the Parties desire to extend the term an additional one (1) year
17 period and add \$500,000 for a total not to exceed amount of \$1,000,000;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions herein contained, the parties agree as follows:

20 1. Section 1.A. of the Agreement is hereby amended to read as follows:

21 "1. SCOPE OF WORK OR SERVICES.

22 A. Consultant shall furnish specialized services more particularly
23 described in Exhibit "A", attached to this Agreement and incorporated by this
24 reference, in accordance with the standards of the profession, and City shall pay for
25 these services in the manner described below, not to exceed One Million Dollars
26 (\$1,000,000), at the rates or charges shown in Exhibit "B".

27 2. Section 2 of the Agreement is hereby amended to read as follows:

28 "2. TERM. The term of this Agreement shall commence at midnight on

1 August 1, 2014, and shall terminate at 11:59 p.m. on August 1, 2018, unless sooner
2 terminated as provided in this Agreement, or unless the services or the Project is
3 completed sooner.”

4 3. Except as expressly modified herein, all of the terms and conditions
5 contained in Agreement No. 33499 are ratified and confirmed and shall remain in full force
6 and effect.

7 IN WITNESS WHEREOF, the parties have caused this document to be duly
8 executed with all formalities required by law as of the date first stated above.
