SUBJECT: Public Walkways Occupancy Permit for Sidewalk Dining at E.J. Malloy's Restaurant Located at 4306 Atlantic Avenue (District 8)

DISCUSSION

E.J. North, LLC, the operator of the E.J. Malloy's Restaurant, requested a first time permit to temporarily occupy part of the adjoining sidewalk at 4306 Atlantic Avenue with portable fixtures, for the purpose of sidewalk dining. The proposed permit area and a list of furnishings and accessories are shown on the attached Exhibit A. Approval of this permit is based on the conditions and standards of Chapter 14.14 of the Long Beach Municipal Code, which describes temporary uses of public rights-of-way. The width of the sidewalk at this location is 12 feet and a minimum clearance of five feet shall be maintained between the permit area, the street tree and a traffic signal adjacent to the restaurant.

The subject permit was prepared by Deputy City Attorney Lisa Peskay Malmsten on May 20, 2004.

TIMING CONSIDERATIONS

City Council action on this matter is not time critical.

FISCAL IMPACT

A permit processing fee of \$500.00 was deposited to the General Fund (GP 100) in the Department of Public Works (PW).
