

RESOLUTION NO. RES-07-0011

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH MEASUREMENT CONTROL SYSTEMS WITHOUT ADVERTISING FOR BIDS FOR FURNISHING ELSTER AMERICAN GAS REGULATORS AND METERS

WHEREAS, the Long Beach Gas & Oil Department ("LBGO") requires to purchase natural gas flow regulators and meters in order to uphold current customer service and safety standards maintained by LBGO; and

WHEREAS, LBGO currently uses flow regulators and meters manufactured by Elster American Meters ("Elster American"); and

WHEREAS, LBGO currently possesses an inventory of replacement parts for such Elster American flow regulators and meters and LBGO employees are trained to repair and maintain such flow regulators and meters; and

WHEREAS, Measurement Control Systems is the only dealer authorized to sell Elster American flow regulators and meters to municipalities located in southern California; and

WHEREAS, no useful purpose would be served by advertising for bids for Elster American flow regulators and meters and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. That the above recitals are true and correct and are incorporated herein.


Sec 3 . This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify to the vote adopting this resolution.
