3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO SUBMIT A GRANT APPLICATION AND ALL
6 REQUIRED SUPPORTING DOCUMENTATION TO
7 RECEIVE LOS ANGELES COUNTY FOURTH
8 SUPERVISORIAL DISTRICT EXCESS FUNDS FOR USE ON
9 VARIOUS PROJECTS BY THE DEPARTMENT OF PARKS,
10 RECREATION AND MARINE IN THE CITY OF LONG
11 BEACH

13 WHEREAS, in July 2011, the Los Angeles County Board of Supervisors
14 approved the allocation of \$450,000 in excess funds available from the Los Angeles
15 County Fourth Supervisorial District pursuant to the Safe Neighborhood Parks
16 Proposition of 1996, for recreation or open space projects in the City of Long Beach; and

17 WHEREAS, if said grant funds are approved by the County, the Department
18 of Parks, Recreation and Marine (PRM) fully intends to utilize these funds for projects
19 that are in need of funding and which represent the greatest recreational and open space
20 needs within the City; and

21 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
22 follows:

23 Section 1. That the above recitals are true and correct and are
24 incorporated herein by this reference.

25 Section 2. That the City Manager is hereby authorized and directed to
26 submit an application to the County for grant funds as described herein.

27 Section 3. The City Manager is hereby authorized to accept all funds,
28 execute and submit all documents including but not limited to applications, agreements,

1 amendments, and all other documents which may be necessary for the receipt of grant
2 funds, and implement and administer the funds and all things related to the various
3 projects that will be undertaken with said funds.


4 Section 4. This resolution shall take effect immediately upon its adoption by
5 the City Council, and the City Clerk shall certify the vote adopting this resolution.
