1 FIRST AMENDMENT TO AGREEMENT NO. 33777

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33777 is made and  
4 entered, in duplicate, as of December 21, 2015 for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 December 2, 2014, by and between RRM DESIGN GROUP, a California corporation  
7 ("Consultant"), with a place of business at 3765 S. Higuera Street, Suite 102, San Luis  
8 Obispo, California 93401, and the CITY OF LONG BEACH, a municipal corporation  
9 ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to  
11 be performed in connection with on-call planning consulting services; and

12 WHEREAS, the parties entered into Agreement No. 33777 whereby  
13 Consultant agreed to provide these services; and

14 WHEREAS, the parties desire to increase the Agreement amount by  
15 \$250,000 for a total not to exceed amount of \$450,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
17 conditions in this Agreement, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 33777 is hereby amended to read as  
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly  
22 described in Exhibit "A", attached to this Agreement and incorporated by this  
23 reference, in accordance with the standards of the profession, and City shall pay  
24 for these services in the manner described below, not to exceed Four Hundred  
25 Fifty Thousand Dollars (\$450,000), at the rates or charges shown in Exhibit "B".

26 2. Except as expressly modified herein, all of the terms and conditions  
27 contained in Agreement No. 33777 are ratified and confirmed and shall remain in full  
28 force and effect.
