3 A RESOLUTION OF INTENTION TO VACATE A
4 PORTION OF ESTHER STREET WEST OF JUDSON
5 AVENUE, IN THE CITY OF LONG BEACH, COUNTY OF
6 LOS ANGELES, STATE OF CALIFORNIA, PURSUANT TO
7 THE PUBLIC STREET, HIGHWAYS AND SERVICE
8 EASEMENTS LAW (DIVISION 9, PART 3, CALIFORNIA
9 STREETS AND HIGHWAYS CODE); FIXING A TIME AND
10 PLACE FOR HEARING ALL PERSONS INTERESTED IN
11 OR OBJECTING TO THE PROPOSED VACATION

13 The City Council of the City of Long Beach resolves as follows:

14 Section 1. The City Council of the City of Long Beach hereby elects to
15 proceed under Division 9, Part 3, Chapter 3, of the California Streets and Highways Code
16 (Section 8320 *et seq.*), as amended, generally known and referred as the "Public Street,
17 Highways and Service Easements Law", and hereby declares its intention to vacate a
18 portion of Esther Street west of Judson Avenue, in the City of Long Beach, County of Los
19 Angeles, State of California, described more particularly as follows:

20 That portion of Esther Street as shown on the map of Tract
21 No. 2600, recorded in Book 26, pages 88 through 90 of
22 Maps, in the County of Los Angeles, lying easterly of the
23 southerly prolongation of the easterly line of lot 23, block 16
24 of said Tract No. 2600 and westerly of the west line of
25 Judson Avenue, 60 feet wide, as shown on said Tract No.
26 2600.

27 Reserving an easement for public utility purposes over the
28 above described parcel of land.

1 The above described parcel of land contains 13,500 square
2 feet, more or less.

3 Section 2. All of the foregoing real property is shown on the map or plan
4 thereof, attached hereto as Exhibit "A", and on file in the office of the City Clerk, which
5 map or plan is known and referred to as "City of Long Beach Department of Public Works
6 Vacation Sketch No. 1004V".

7 Section 3. The City Council hereby fixes the 16th day of December, 2014
8 at the hour of 5:00 p.m., as the time and the City Council Chamber, Plaza Level of the
9 City Hall, 333 West Ocean Boulevard, in the City of Long Beach, California, as the place
10 for hearing all persons interested in or objecting to the proposed vacation.

11 Section 4. The City Council hereby directs that notice of said hearing on
12 this proposed street vacation be published for at least two (2) successive weeks prior to
13 the hearing and in the manner provided by Section 8322 of the State Streets and
14 Highways Code.

15 Section 5. The City Council hereby directs that notice of this street
16 vacation be posted conspicuously along the street proposed to be vacated at least two
17 (2) weeks before the date set for hearing and in the manner provided by Section 8323 of
18 the State Streets and Highways Code.

19 Section 6. This resolution shall take effect immediately upon its adoption
20 by the City Council, and the City Clerk shall certify to the vote adopting this resolution.

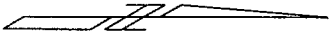
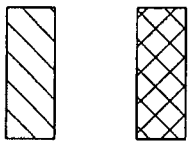
