## DISCUSSION

Pursuant to Section 34090 of the California Government Code and Chapter 1.28 of the Long Beach Municipal Code, records destruction for City Manager departments and elected officials must be submitted to the City Council for approval. In its capacity as responsible agent for the operation of the Records Center, the City Clerk Department has worked with the department listed to review the records destruction (Exhibit A).

19 under its charge and are no longer required for use in its respective office, said records  
20 being no less than two (2) years old.

- 22 A. Affect the title to real property or liens thereon;  
23 B. Constitute official court records;  
24 C. Constitute records which are required to be kept by statute;  
25 D. Constitute the original or record copies of the minutes,  
26 ordinances or resolutions of the City of Long Beach or any City Board or  
27 Commission.
