3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH PROVIDING FOR A TEMPORARY
5 AMNESTY PROGRAM WAIVING LATE PENALTY FEES
6 FOR DOG LICENSES THROUGH SEPTEMBER 30, 2015

8 WHEREAS, on March 17, 2015, the City Council adopted ORD-15-0008
9 which will go into effect on October 1, 2015, requiring pet owners, among other things, to
10 spay or neuter their dogs, unless they possess a medical exclusion or exemption; and

11 WHEREAS, in an effort to encourage residents to make their licenses
12 current by waiving late fees for dog licenses, an amnesty program, leading up to the
13 implementation of the new mandatory spay/neuter law for all dogs over six months, would
14 eliminate the associated expired license penalty of \$30.00 through September 30, 2015;

15 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
16 follows:

17 Section 1. The Director of Parks, Recreation and Marine ("Director") shall
18 develop and administer a temporary Amnesty Program waiving late penalty fees for dog
19 licenses through September 30, 2015.

20 Section 2. The Director shall waive the thirty dollar (\$30) late penalty fee
21 imposed under the Long Beach Municipal Code Section 6.08.040 under the Amnesty
22 Program.

23 Section 3. The Amnesty Program shall apply to any dog owner who
24 makes their dog licenses current by mail or in person during the month of September,
25 2015.

26 Section 4. This resolution shall take effect immediately upon its adoption
27 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
