

FIRST AMENDMENT TO AGREEMENT NO. 32454

THIS FIRST AMENDMENT is made and entered into, in duplicate, as of February 18, 2014, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on October 11, 2011, by and between the CITY OF LONG BEACH, a municipal corporation ("City") and LONG BEACH COMMUNITY ACTION PARTNERSHIP (LBCAP), a California non-profit corporation ("Contractor").

WHEREAS, the City and Contractor executed Agreement No. 32454 on January 20, 2012, wherein Contractor agreed to serve as City's Designated Public Access Provider; and

WHEREAS, the parties desire to exercise the first of their two options to extend the term of the Agreement for an additional year;

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained in the Agreement and herein, the parties agree as follows:

1. Section 3.0(A) of Agreement No. 32454 is deleted in its entirety and amended as follows:

**"SECTION 3.0 TERM OF AGREEMENT.**

A. The term of this Agreement shall commence on January 10, 2014 and terminate on January 10, 2015. The City shall have the option at their discretion of extending the term for one (1) additional year."

2 Except as expressly amended herein, all terms, covenants and conditions in Agreement No. 32454 are ratified and confirmed and shall remain in full force and effect.
