

1 FIRST AMENDMENT TO AGREEMENT NO. 30799

3 THIS FIRST AMENDMENT is made and entered, in duplicate, as of July
4 16, 2009 for reference purposes only, pursuant to a minute order adopted by the City
5 Council of the City of Long Beach at its meeting held on July 22, 2008, by and between
6 LANGHAM CONSULTING SERVICES, INC., a Louisiana corporation, with a place of
7 business at 2240 Monroe Street, Mandeville, Louisiana ("Consultant"), and the CITY OF
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties executed Agreement No. 30799 in August of 2008
10 wherein consultant agreed to perform specialized services in connection with the
11 selection of a new customer information system ("CIS") in the City of Long Beach
12 ("Project"); and

13 WHEREAS, now the parties desire to extend the term for an additional
14 year;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions in this Agreement, the parties agree as follows:

17 1. Section 2 of Agreement No. 30799 is hereby amended and deleted
18 in its entirety to read as follows:

19 "2. TERM. The term of this Agreement shall commence on August 1,
20 2008, and shall terminate on July 31, 2010, unless sooner terminated as
21 provided in this Agreement, or unless the services to be performed
22 hereunder or the Project is completed sooner."

23 2. Except as expressly amended herein, all of the terms, covenants and
24 conditions of Agreement No. 30799, as amended and to the extent not contrary to this
25 First Amendment, shall remain unchanged and in full force and effect.
