1 FIRST AMENDMENT TO AGREEMENT NO. 32391

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32391 is made and
4 entered, in duplicate, as of February 15, 2014 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 8, 2011, by and between LINK2GOV CORP., a Tennessee corporation (a
7 wholly-owned subsidiary of FIDELITY NATIONAL INFORMATION SERVICES, INC.)
8 ("Consultant"), with a place of business at 113 Seaboard Lane, Suite A-250, Franklin,
9 Tennessee 37067, and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with credit card processing services; and

12 WHEREAS, the parties entered Agreement No. 32391 whereby Consultant
13 agreed to provide such services; and

14 WHEREAS, the parties desire to extend the term and add \$160,000 for a
15 total not to exceed amount of \$640,000;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions in
17 the Agreement and in this First Amendment, the parties agree as follows:

18 1. Section 2 of Agreement No. 32391 is hereby amended to read as
19 follows:

20 "2. TERM. The term of this Agreement shall commence at midnight on
21 May 1, 2011, and shall terminate at 11:59 p.m. on April 30, 2015, unless sooner
22 terminated as provided in this Agreement, or unless the services or the Project is
23 completed sooner. The parties have the option to renew this Agreement for one (1)
24 additional one (1) year period, at the discretion of the City Manager."

25 2. Except as expressly amended in this First Amendment, all terms and
26 conditions in Agreement No. 32391 are ratified and confirmed and shall remain in full
27 force and effect.
