#### **RECOMMENDATION:**

Receive the supporting documentation into the record, conclude the hearing and grant the Permit, with or without conditions, or deny the Permit on the application of Derry 207, DBA Gallagher's Pub & Grill, 2751 E. Broadway, for a Permit for Entertainment With Dancing by Performers at an existing restaurant. (District 2)

#### **DISCUSSION**

The Long Beach Municipal Code (LBMC) requires an application be filed and a hearing be held before the City Council whenever this type of activity is requested and before a license or permit is granted or denied.

The LBMC also requires that the City Council make a determination that the application is complete and truthful; the applicant, the person interested in the ownership and operation of the entity, and the officers and trustees of the entity are law-abiding persons who will operate and conduct the business activity in a lawful manner; and, that the public peace, welfare, and safety will not be impaired. If this is so, the application shall be approved; if not, it shall be denied.

Attached for your review is the application from Derry 207, DBA Gallagher's Pub & Grill. Also attached are reports from various departments and a summary of those reports, as well as the license history of the establishment.

City departments have conducted their investigation in accordance with the LBMC. The following summarizes their findings:

- The Police Department recommends that the permit for entertainment with dancing by performers be approved with conditions.
- The Fire Department recommends that the permit for entertainment with dancing by performers be approved.

- The Health and Human Services Department finds that the building/location meets department requirements for the proposed use with the condition that the establishment remain in compliance with the Long Beach Noise Ordinance (LBMC Chapter 8.80).
- The Planning and Building Department recommends that the permit for entertainment with dancing by performers be approved.

In the event that any of the recommended conditions attached to any permit or licenses are in conflict, the permittee shall adhere to the strictest of the applicable conditions. This location has been licensed as a restaurant since December 2001.

#### TIMING CONSIDERATIONS

The hearing date of August 14, 2007, has been posted on the business location, with the applicant and property owners within 300 feet notified by mail. Derry 207, DBA Gallagher's Pub & Grill, is operating on a temporary permit that expires on August 15, 2007.

Deputy City Attorney Cristyl Meyers reviewed this report on August 1, 2007.

#### FISCAL IMPACT

The following fees were collected with the application: Building Inspection \$290.00 and Zoning Review \$14.00 (Planning and Building Department), Police Investigation \$1,000.00 (Police Department), Temporary Permit \$300.00, Labels \$90.00 (Financial Management Department), and Health/Noise Control \$94 (Health and Human Services Department.

The following fees will be collected if the application is approved: Business License \$299.88 and Regulatory \$250.00 (Financial Management Department).

All fees are deposited in the General Fund.



APPLICATION FOR ENTERTAINMENT WITH DANCING BY PERFORMERS ONLY AT GALLAGHER'S PUB & GRILL – 2751 EAST BROADWAY

In response to your request for a recommendation regarding the above named permit application for Entertainment With Dancing by performers only, the Police Department recommends **approval**, subject to the following sixteen (16) conditions of operation:

Gallagher's Pub & Grill is a restaurant located on the north side of Broadway between Molino Avenue and Temple Avenue. They have a capacity of 80 people. The establishment serves Irish food for lunch and dinner, and offers entertainment during the evening hours. Vice Detectives believe that the approval of this application, with specific conditions, would mitigate any existing community concerns.

#### **CONDITIONS OF OPERATION**

- 1) The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- 2) Unless separately applied for, reviewed and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC shall be conducted on the permitted premises.
- 3) Entertainment activities indicated on page #7 of your entertainment application shall be restricted to no later than 10 p.m. Sunday through Thursday nights, and midnight on Friday and Saturday nights. There shall be no outdoor entertainment allowed at anytime.
- 4) Noise emanating from the permittee's business shall not be audible 50 feet (50') from the exterior of the premises in any direction. The permittee shall be responsible for determining how to best meet this requirement, either by keeping doors and windows shut, limiting hours of entertainment or by offering non-amplified entertainment.
- 5) Entertainment shall be accessory to the primary business, which is a restaurant. The permittee shall not hire promoters with the intent to advertise/promote or hold any entertainment activities consistent with nightclub entertainment.

- The premises shall be maintained as a full service restaurant providing an assortment of full meals normally offered in such establishments. In the event that the restaurant ceases operations, the entertainment permit becomes null and void.
- 7) The permittee shall not allow employees to discard trash or beer bottles into the outside dumpster between the hours of 10 p.m. and 7 a.m.
- The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors and the parking lot, at all times open for business. This should be done by use of security guards and/or signage indicating, words to the effect of, "Please respect our neighbors."
- 9) The permittee shall not allow any employee, patron or entertainer, to exit or loiter near the two rear doors of the business after 10 p.m., each day of the week.
- 10) The permittee shall be responsible for maintaining an adequate staff during any entertainment activity, to supervise patrons inside the establishment and those waiting to enter. Potential patrons awaiting entry in a defined "queue" shall be counted toward the calculation of required staffing levels. For crowds up to fifty (50) people the permittee shall provide a minimum of one (1) staff member. For crowds over fifty people the permittee shall provide a minimum of one (1) additional staff member per fifty (50) people. Staff members must be identifiable as "Gallagher's employees." Should the permittee's operations give rise to a substantial increase in complaints/calls for service, or trash left in the parking lot, the permittee shall increase staff, or employee uniformed licensed security guards, as directed by the Chief of Police.
- 11) At the conclusion of each event, the permittee shall take reasonable measures to ensure that exiting patrons walk directly to their vehicles, and not loiter in the immediate area.
- 12) Current occupancy loads shall be posted at all times, and the permittee shall have an effective system to keep count of the number of occupants present at any given time and provide that information to public safety personnel upon request. (LBMC section 18.48.320)
- 13) The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.

- 14) Gallagher's or its agents, shall not distribute any advertising matter, such as signs, posters, or promotional cards, in or upon any public property, or in or on any vehicle in any such place in the City. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter.
- The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances and stated conditions. In the event of a conflict between the requirements of this permit, your conditional use permit, or your Alcoholic Beverage Control license, the more stringent regulation shall apply.
- The permittee, shall, within ninety (90) days of an approved entertainment permit, submit proof of attending the LEAD program offered by the Department of Alcoholic Beverage Control. In the event that the LEAD program class is not offered within this ninety day period, the permittee shall attend the next available class. Proof of completion shall be submitted to the Long Beach Police Department Vice Investigations Section.
